In exercise of the powers conferred by subsection (1) of section 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act 27 of 1996), the Government of Kerala hereby make the following rules further to amend the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Kerala Rules, 1998

issued by notification under G.O.(P) No. 53/98/LBR dated 14th August 1998 and published as S.R.O.No.720/98 in the Kerala Gazette Extraordinary No. 1366 dated 17th August 1998, namely:-

Rules

1. Short title and commencement.-(1) These rules may be called the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Kerala Rules, 2024.

2. They shall come into force at once.

3.Amendment of Rules.- In the Building and Other Construction Workers'(Regulation of Employment and Conditions of Service) Kerala Rules, 1998 in sub-rule (2) of rule 284, the following proviso shall be added,namely:-

"Provided that,if a beneficiary commits default in the payment of contribution for more than three years, the membership shall not be resumed."

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala Building & Other Construction Workers' Welfare Board has submitted a proposal to the Government that the Building & Other Construction Workers' (Regulation of Employment and Conditions of Service) Kerala Rules, 1998 may be amended to make necessary changes in rule 284 to fix the maximum period for the resumption of lost membership due to the default in the payment of contribution to the fund. Now, therefore, the Government have decided to amend the above said rules suitably.

The notification is intended to achieve the above object.
