In exercise of the powers conferred by sub-section (1) and (2) of Section 71 of the Indian Partnership Act, 1932 (Central Act IX of 1932), Government of Kerala hereby make the following further amendment to the Kerala Partnership (Registration of Firms) Rules, 1959, published in Kerala Gazette No.18 dated 5th May,1959 namely-



RULES

1. *Short title and commencement.* - (1) the Kerala Partnership (Registration of Firms) (Amendment) Rules, 2025.

(2) They shall come into force at once

2. *Amendment of Rules.*-In the Kerala Partnership (Registration of Firms) Rules, 1959, in Form,-

(a) in Form A, for the entries against item number 5, the following entries shall be substituted, namely:-

"Address	Date of Change	Remarks
Official phone number		
Official e-mail id";		

(b) in Form 1, for the words, brackets, letters and symbol "place of business (a) Principal place (b) Other places." the following words, brackets, letters, symbol shall be substituted, namely:-

"Place of Business	(a) Principal Place
	(b) Other places
	(c) Official phone number
	(d) Official e-mail id";

(c) in Form II, for the words and brackets "Principal place of business (Previous place) (New place)" the following words, brackets and symbol shall be substituted, namely:-

"Principal place of business	(Previous place)
	(New place)
Official phone number	(Previous Number)
	(New Number)
Official e-mail id	(Previous e-mail id)
	(New e-mail id)."

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The registration of partnership firms are now being carried out online. For the purpose of submitting online applications, receiving one-time passwords, registration certificates, and other communications, the mobile number and email address of the applicants are required to be provided on the official portal. Hence the Government have decided to amend the Kerala Partnership (Registration of Firms) Rules, 1959, suitably to ensure that the mobile number and email address of the applicants are incorporated into the various forms annexed to the said rules.

The notification is intended to achieve the above object.
