CIRCULAR

Sub: - Clarification on categorisation of sectors under Red, Orange, Green, White and Blue categories

Ref: -

- 1. Directions issued by Central Pollution Control Board (CPCB) under section 18(1)(b) of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 regarding harmonisation of classification of sectors under Red, Orange, Green, White and Blue categories issued vide CPCB letter dated 12.02.2025
- 2. Circular No. KSPCB/258/2025-SEE-1 dated 28/03/2025

As per directions issued by Central Pollution Control Board (CPCB) referred 1st, Board has adopted the revised classification of sectors under Red, Orange, Green, White and Blue categories vide Circular referred 2nd. Some of the sectors classified by Kerala SPCB during the period from 2016 to 2025 either became redundant or there were contradictory sectors in the new CPCB classification. Such sectors in the classification by Kerala SPCB are either deleted or put into more appropriate sectors as detailed in Annexure I.

Some of the major changes are explained further as follows:

- 1. Quarrying operations (Granite/Laterite/Clay etc.) sub sector 'Mining of minor minerals (except Sand/riverbed material mining)' in orange category.
- 2. 'Carpentry & wooden furniture manufacturing without spray painting (excluding saw mill) with the help of electrical (motorized) machines such as electrical wood planner, steel saw cutting circular blade, etc' has been categorised as White.

The sector 'Furniture manufacturing or assembling units using MDF, particle board, novo pan, plywood and other similar engineered wood (manufactured board)' is also recategorised to White.

- 3. All Non Bedded Health Care Facilities shall obtain Consent to Establish/Operate of the Board which is integrated with authorisation under Biomedical Waste Management Rules, 2016. These units are categorised under Green (Separate circular will be issued for handling consent/authorisation applications of such establishments).
- 4. Cattle/Dairy Farms having animals 15 to 500 nos has been categorised under Orange category and Dairy Farm having more than 500 animals in Red category.

 Dairy farms having less than 15 animals do not require separate classification.

- 5. The categorisation related to printing units are as follows;
 - 5 (1) Digital printing units, which does not involve any wastewater generation shall apply for consent in the sector 'Digital Printing on flex /vinyl, PVC etc. (more than 5 machines)' under Green. Such units having number of machines 5 and below need not obtain consent of Board.
 - 5 (2) Units engaged in printing other than digital may apply for consent under sectors in Orange category namely, 'Printing press (newspaper, books, magazines, etc./ Gravure printing' or 'Printing (other than digital) in banners of approved material'
- 6. As per the revised classification of CPCB, 'Building construction project ≥ 20,000 sq. m. built-up area' is categorised under Orange and 'Building construction project ≥ 5,000 sq. m., but < 20,000 sq. m. built-up area (without connectivity to terminal STP)' is categorised under Green. It is also specified that Building construction project ≥ 5,000 sq. m., but < 20,000 sq. m. built-up area (with connectivity to terminal STP) may not require separate classification.

Taking into account the unavailability and connectivity to terminal STP, except in one or two cities, the potential of air pollution and solid waste generation, high population density and environmental complaints, the sectors 'Residential buildings' and Hostel/Guidance centre, Office /Commercial buildings' categorised by Kerala SPCB as per Circular PCB/T4/115/97 dated 07-Oct-22 based on built up area and waste water generation shall continue to be in force.

- 7. Only 'Bakery, confectionery, sweets with production capacity ≥ 1 TPD' has been categorised by CPCB. Such units (Bakery, confectionery, sweets) having production capacity less than 1 TPD is hence exempted from the consent purview.
- 8. As per CPCB directions, standalone genset(s) of total capacity less than 1000 KVA may not require additional classification. However the used oil/waste oil generated during repair and maintenance need to be disposed through authorized hazardous waste recycler by service provider/OEM.

Hence the sector 'DG set attached to retail shop/ other establishments having area less than 2000 sqm' categorised by Kerala SPCB vide Circular No. PCB/T4/115/97(i) dated 10-Feb-2022is cancelled.

Also 'Mobile towers using genset' has been categorised under Green. Accordingly, all such units shall obtain consent of Board under Green category. Circulars PCB/T4/115/97 dated 17-Mar-17 and PCB/T4/115/97 18-Nov-20 is cancelled.

The revisions in classification of industrial/non industrial sectors are enclosed as Annexure-I. All pending Consent applications shall be processed accordingly.
