CDSL is pleased to announce addition of new features in the Audit Web Portal accessible through DP login. These enhancements have been implemented to provide greater visibility and facilitate efficient tracking of compliance-related submissions, enabling you to monitor the status of your filings with ease and also ensure timely compliance with regulatory requirements.

DPs will now be able to access the following information directly through their login:

“View Pending Submissions”

This option will display list of all mandatory reports along with schedule month & final due dates that are yet to be submitted. DPs are required to review this section regularly for timely compliance.
