Notification Bhubaneswar, dated 94-7-25

No. LESI-LL2-FM-0008-2025- 674 /LESI., Whereas the proviso to clause (b) of sub-section (1) of section 66 of the Factories Act, 1948 as amended vide the Factories (Odisha Amendment) Act, 2020, provides that the State Government may, by notification, allow women workers to work with their consent even between the hours of 7.00 p.m. and 6.00 a.m. in any factory, if the State Government is satisfied that the factory has taken adequate safety, security, welfare measures and such safeguards as notified by the State Government, from time to time.

Now, therefore, to expand employment opportunities for women in Factories and for Ease of Doing Business, the Government after careful consideration and in exercise of the said powers, do hereby allow the Registered Factories in the State to engage women workers between 7.00 p.m. and 6.00 a.m., subject to the following conditions:-

- 1. The consent of women workers willing to work in night shift shall be taken in writing;
- 2. No woman shall be employed against the maternity benefit provisions laid down under the Maternity Benefit Act, 1961;
- 3. Adequate transportation facilities with GPS tracking system shall be provided to women workers to pick-up and drop near their residence;
- 4. The Occupier of a Factory shall provide separate toilet and washroom facilities;
- The Occupier of a Factory with over 30 women workers shall provide crèche facilities or arrange crèche facilities from voluntary or other organizations during night shift;
- 6. The work place including passage towards conveniences or facilities concerning toilet, washrooms, drinking water, entry and exit of women or any area used by women workers should be well-lit, near the work place where women work and preferably have suitable provisions of closed-circuit television (CCTV) surveillance;

- 7. Boarding and lodging for women workers, where applicable, shall be kept exclusively for women under the control of women wardens or supervisors;
- Dedicated telephone numbers of the establishment along with Government Tollfree Helpline number for Women (181) and Labour and ESI Department Helpline number 18003456703 shall be displayed prominently and conspicuously at the establishment and inside vehicles used for transportation of workers;
- 9. Any Occupier employing women during night shift, shall submit a Self-certification in the prescribed proforma, electronically, in the designated portal of the Department, that he or she has provided all the facilities as mentioned in this Notification and shall take due care and diligence regarding the safety, security and dignity of women workers;
- 10. If any Factory fails to comply with the above conditions, then the Occupier and Manager of the said Factory shall be liable for penalty under section 92 of the Factories Act, 1948.
