AVAILABILITY OF CDSL SYSTEM AND MULTIPLE SETTLEMENTS ON ACCOUNT OF MUHURAT TRADING ON OCTOBER 21, 2025

As informed by the Clearing Corporations (ICCL & NCL) on account of Diwali Laxmi Pujan, Muhurat Trading session is scheduled to be conducted on Tuesday, October 21, 2025. DPs are advised to take note of the following:

- Inter-Depository Transactions (IDT) for Non-Government Securities (**Non GSec**) will be allowed on Tuesday, October 21, 2025 till 9:30 PM.
- On-Market Inter-Depository Transactions (IDT) for Government Securities (**GS**) between depositories will not be exchanged on Tuesday, October 21, 2025 and hence DPs will not be allowed to enter On-Market Inter-Depository Transactions (IDT) for Government Securities on the said date.
- CDSL system (WEB CDAS & Easiest) will be available to users for execution of all other type of transactions on the said date till scheduled EOD at 10:00 PM.
- The reports will also be generated with business date as October 21, 2025.
- Rate Files will be available for the said trading date.
