INTRODUCTION OF NEW REPORT - "DPT9" FOR CLOSURE OF DEMAT ACCOUNTS WITH STATUS "TO BE CLOSED"

DPs are advised to refer Communique no. CDSL/OPS/DP/POLCY/2025/308 dated May 09, 2025, regarding the closure of demat accounts with status "To be closed".

In this regard, it is reiterated that whenever ISINs are activated or free balances become available in a demat account with the status "To be closed", DPs shall immediately process the transfer of such ISINs to the target demat account and ensure closure of the said account in a timely manner.

To facilitate the said process, CDSL is pleased to inform DPs about the introduction of a new report "To be closed BO with free balance", which will provide details of "To be closed" BOs with free balances. This report will be generated in EOD for BO's in "To be closed" status having free balance. The report can be downloaded from Reports module by entering Module ID – "11" and Report ID – "DPT9".

DPs have to refer the said report and complete the transmission / transfer process and close (as per guidelines provided in DP Operating Instructions) the respective demat account/s as soon as transferable balances are available in the "To be closed" accounts.

DPs are requested to refer to the attached Annexure-A for file format of the new Report "DPT9". DPs are advised to take note of these changes and initiate back-office changes, if any. The above functionality is tentatively scheduled for live release on October 31, 2025, EOD.
