CIRCULAR

Sub:- Auto renewal of consent application

As part of the Ease of Doing Business initiative, the Board is implementing Auto renewal procedure for consent management for speedy disposal of consent renewal applications.

The renewal of consent will be generated automatically based on the self-declaration (Format enclosed as Annexure) submitted by the occupier subject to the following :

- All other conditions of the Integrated Consent to Establish/Operate issued earlier remain complied in the unit
- There are no court cases or complaints against the unit.
- Undertaking that all relevant statutory provisions of the Board as well as norms and instructions issued by the Board from time to time will be complied.
- This consent is liable to be cancelled and the occupier will be penalized if any of the information/statements/documents therein are found incorrect/false/partial/forged/ misleading
- There shall be no change or alteration to the industry/operation/activities from that specified in the previous consent(s).

Auto-renewal facility can be availed for all renewal applications irrespective of capital investment *except* for the following cases;

1. Red Category Industries
2. Any activity requiring a valid Environment Clearance (EC)
3. Units requiring temporary consent (eg. Brick kiln/temporary crushers/hot mix plant etc.)

Necessary modifications shall be made in the consent management web portal of the Board so that auto renewal can be implemented with effect from 01.11.2025

- vii. That, there are no complaints or court cases against the unit and there are no prohibitory directions against the unit/occupier issued by the Courts/ National Green Tribunal/Appellate Authority/other Judicial/Quasi Judicial Authority.
