### New version of Trading Software

---

In terms of the provisions of the Rules, Bye-Laws and Business Rules of the Exchange, the Members of the Exchange are notified as under:

Trading Members may note that an Improvement to the existing trading software (**MCX MTS V14.0.2.98 and MCS V14.0.2.77**) with optimized version is planned to be released effective from **Wednesday, December 31, 2025**.

Members are requested to take note of the following:

- This is a compulsory download. The version of **MTS V14.0.2.98 and MCS V14.0.2.77 will however remain the same**. The setup will be available on SFTP server (Extranet) from Tuesday, December 30, 2025, after trading hours.
- Procedures for downloading and installation of new trading software are specified in **Annexure 1**.
- The new trading software should be installed only after close of market hours of Tuesday, December 30, 2025, after taking the online back-up, trade report etc. for the day.

## Annexure - 1

### Steps for downloading and installation of the new version of trading software:

- MTS installation guide is available on <https://sftp.mcxindia.com> (file name MTS\_Installation\_Guide\_V.1).
- It is Mandatory for Member's to install new version of MTS/MCS manually kept on Sftp.
  - **MTS- V14.0.2.98**
  - **MCS- V14.0.2.77**

Members should compulsorily follow below steps for Manual installation:

- 1) Uninstall the previously installed Production MTS and MCS setups from the machine.
- 2) Go to C > Program Files (x86) > Tata Consultancy Services > MCX-Trade Station (MTS) folder and delete all files/sub folders from this folder.
- 3) Go to C > Program Files (x86) > Tata Consultancy Services > MCX-Member Control Station (MCS) folder and delete all files/sub folders from this folder.
- 4) Go to App Data > Local > select both MCX\_MTS 140000 and MCX\_MCS 141000 and delete both folders.
- 5) Setup is available on SFTP at path Common/Setup/CDPLiveSetup on **Tuesday, December 30, 2025, after market hours.**
- 6) Download the setup from **Common/Setup/CDPLiveSetup** folder in the SFTP (Extranet) Server on <https://sftp.mcxindia.com>.
- 7) Install both newly downloaded MTS and MCS setups.
- 8) After installation, members/users must **replace the AppConfig.xml file** available in the Common/Setup/CDPLiveSetup folder at the below mentioned paths:
  - **MCS:** C: > Program Files (x86)\Tata Consultancy Services\Member Control Station (MCS)\
  - **MTS:** C:\Program Files (x86)\Tata Consultancy Services\Member Trade Station (MTS)\

*Further please follow the aforesaid guidelines for installation.*

- Members are required to unzip installable file "MTS- V14.0.2.98.Zip"
  - to install **The MCX Trade Station (MTS).msi** or Setup.exe.
  - Member are required to unzip installable file "MCS- V14.0.2.77.Zip".
  - to install Member Control Station (MCS) MCX Member Control Station (MCS).msi.

- Members using MTS facility and having specific local firewall access rules need to ensure that access to IP Address should be enabled at their end for seamless connectivity to Exchange trading system.
- It is recommended to whitelist software which may hinder seamless broadcast dissemination for the machines on which MTS application is installed
- Members are requested to uninstall and install the latest application available on sftp as mentioned in circulars.
- Ensure Admin Access is provided to installation path (C:\Program Files (x86)\Tata Consultancy Services)
- The “Load Script File from Local Path” option should always be unchecked by default.
