#### **ORDER**

The 4th August, 2023

**No.S.O. 64/P.A.12/2019/S.63/2023.-** Whereas there is no provision in the Punjab Transparency in Public Procurement Act, 2019 (Punjab Act No.12 of 2019) regarding direct purchase from the entities of Government of Punjab and Government of India or entities which are under the control of Government of Punjab and Government of India, due to which delay occurs in procuring the subject matter of procurement.

Whereas, the National Informatics Centre (NIC) under the Ministry of Electronics and Information Technology (MeitY) is the technology partner of the Government of India with its objective to provide technology-driven solutions to the Central and State Governments and mandate of design and develop Information Technology Systems for the Government, provide Information and Communication Technology Infrastructure to the Government, explore and advise on the use of emerging technologies.

Whereas, National Information Centre Services Inc (NICSI) was established under the National Informatics Centre (NIC), Ministry of Electronics and Information Technology (MeitY), Government of India with a mission to promote and provide transparent value added information and communication technology procurement services and business solutions at competitive prices with a focus on socio economic development.

Whereas, the Government of Punjab, Department of Defence Services Welfare, vide letter No. DSWD-14/10/2020-DSW/1/267887/2021, dated 21-10-2021 has asked all the Departments, Boards, Corporations and other Semi-Government Organizations to engage outsource manpower through the Punjab Ex-Servicemen Corporation Organization (PESCO) where Ex-servicemen are available with PESCO for discharging security duties.

Now, therefore, keeping in view the public interest and above mentioned reasons and in exercise of the powers conferred by sub-section (1) of section

63 of the Punjab Transparency in Public Procurement Act, 2019 (Punjab Act No. 12 of 2019), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to exempt from the ambit of the said Act, the procurement of services (both consultancy and non-consultancy) by procuring entities from the,-

- (i) National Informatics Centre (NIC) under the Ministry of Electronics and Information Technology (MeitY);
- (ii) National Information Centre Services Inc (NICSI) under the National Informatics Centre (NIC), Ministry of Electronics and Information Technology (MeitY), Government of India; and
- (iii) Punjab Ex-servicemen Corporation under the Department of Defence Services Welfare, Punjab.

#### **NOTIFICATION**

The 7th August, 2023

G.S.R. 79/C.A.27/1996/Ss. 40 and 62/Amd.(3)/2023.-In exercise of the powers conferred by sections 40 and 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act No. 27 of 1996), and all other powers enabling him in his behalf, the Governor of Punjab, after consultation with the expert committee, is pleased to make the following rules further to amend the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008, namely:-

#### **RULES**

- (i) These rules may be called the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) (Amendment) Rules, 2023.
  - (ii) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- 2. In the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008 (hereinafter referred to as the said rules), in rule 260, in sub-rule (3), for the words, sign and figures "A certificate from the employer or the contractor in form- XXVII", the following words, signs and figures shall be substituted, namely: -

"A certificate, from the employer or the contractor or any other person or authority or officer who is authorized by the Board, in Form-XXVII".

3. In the said rules, in rule 261, in sub-rule (1), for the words and signs "This contribution shall be remitted in advance once in three months in any of the banks, specified by the Board in the district, in which the member resides.", the following words, signs and figures shall be substituted, namely:-

"This contribution shall be remitted in advance for a period of one year at the time of applying for registration or renewal of registration in any of the banks, specified by the Board in the district, in which the member resides or in cash receipt (as prescribed in form no. XXXIV)".

4. In the said rules, for Form No. XXVII, the following Form shall be substituted, namely: -
