NOTICE

Subject: Invitation of Claims in Respect of Old Security Deposits

It has been observed during the reconciliation of accounts that certain amount of security deposits received by the Warehousing Development and Regulatory Authority (WDRA) prior to **31st March 2021** remain unidentified due to the non-availability of complete records.

Accordingly, Warehousemen who had deposited a security deposit with WDRA prior to **31st March 2021** and has not received the refund, if otherwise eligible, is requested to submit its claim along with supporting documentary evidence. The eligibility for refund of the security deposit deposited with the WDRA will be governed by The Warehousing (Development and Regulation) Registration of Warehouse Rules, 2017.

The claim should be accompanied by the following documents, as applicable:

1. Copy of the security deposit receipt/challan or any other proof of deposit.
2. Name and address of the claimant.
3. Details of the warehouse, warehouse number.
4. Bank account details (cancelled cheque/bank passbook copy) for refund, if the claim is found admissible.
5. Any other supporting documents establishing the claim.

The claim, along with the supporting documents, should reach WDRA within **90 days** from the date of publication of this notice at the following address:

All claims submitted in physical form should be sent in a sealed envelope superscribed:

"Claim for Refund of Security Deposit"

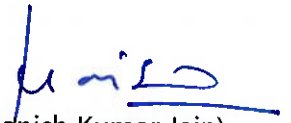
The superscription should be clearly written on the top of the envelope to facilitate identification and prompt processing of the claim.

Claims received after the prescribed period or without adequate supporting evidence may not be considered.

If no claim is received within the stipulated period, WDRA reserves the authority to initiate an appropriate decision regarding the treatment of the unclaimed security deposits.

This notice is issued in the interest of proper accounting and reconciliation of old outstanding security deposits.
