# GSTIN NOTIFIES ADVISORY ON INTRODUCTION OF FORM ENR-03 FOR ENROLMENT OF UNREGISTERED DEALERS/PERSONS IN E-WAY BILL PORTAL FOR GENERATING E-WAY BILL

**Applicability:**

*Applicable to all unregistered dealers, transporters, and entities involved in goods movement without a GSTIN*

A new feature has been introduced in the E-Way Bill (EWB) system, effective from February 11, 2025, allowing unregistered dealers to enroll and generate e-Way Bills. This update is in accordance with Notification No. 12/2024 dated July 10, 2024, and aims to facilitate seamless compliance for businesses engaged in goods transportation without a GST registration.

**Key Benefits of ENR-03 Enrolment**

Enables unregistered persons (URPs) to generate e-Way Bills.

Provides a unique Enrolment ID as an alternative to GSTIN.

**Steps for Enrolment Using Form ENR-03**

- a) Accessing the Form  
Available under the "Registration" tab on the EWB portal.
- b) Filling Out ENR-03  
Select State and enter PAN details (for verification).  
Provide business address and a mobile number (OTP verification required).
- c) Creating Login Credentials  
Choose a username and password to complete registration.  
System generates a 15-character Enrolment ID upon successful submission.

**Using the Enrolment ID for E-Way Bill Generation**

Login to the EWB portal using new credentials.

The Enrolment ID auto-populates in place of Supplier/Recipient GSTIN.

Enter other shipment details to generate an e-Way Bill.

**Compliance Requirement**

All unregistered dealers engaging in goods transportation must enroll and comply with this new regulation.
